### ORDER

As per G.O. read as 1<sup>st</sup> above, all estimates requiring technical assistance from the Government, including PSUs like KSEBL, would adopt the PRICE Software. As per the B.O. read as 2<sup>nd</sup> above, KSEBL adopted PRICE-1 under Other Engineering Organizations (OEO) - a common platform for engineering organisations other than Government departments. The Chief Engineer (C-I&CC) is the nodal officer for PRICE Software implementation in KSEBL. The number of users in PRICE -1 under OEO is very limited and KSEBL is facing acute shortage of band width issues preventing from availing latest features of PRICE -Software version 3 such as E-MBook, E-Bill, Estimate Revision, Dash Board etc. Considering the lack of future technical support for PRICE 1.0, KSEBL has to migrate to PRICE 3.0 with immediate effect.

For the successful implementation of PRICE 3.0 in KSEBL, a Master Coordinator, preferably an Assistant Engineer, has to be appointed as the Point of Contact for the e-governance Cell of PWD and the National Informatics Centre - Kerala. The duties of the Master Coordinator include mapping of seats and user IDs in various wings of KSEBL, creating flowcharts for estimate sanction processes based on current Delegation of Power in force to the e-governance Cell of PWD, updating processes for future changes in Delegation of Power or office hierarchy, documenting technical requirements for E-MBook and E-Bill implementation, offering technical support to Wing Coordinators.

Sri. Anujith K Babu (1108220), Assistant Engineer (Civil), Dam Safety Division, Idamalayar, is



conversant with the preliminary user mapping of PRICE 3.0 and coordinating activities with the e-governance cell and National Informatics Centre - Kerala. Sri. Anujith K Babu (1108220), may be nominated as the Master Coordinator of KSEBL for PRICE 3.0 integration.

It is also suggested to constitute an internal technical committee under the Chairmanship of Deputy Chief Engineer, Civil Circle, Kothamangalam with the following members for the successful implementation of PRICE 3.0 in KSEBL. The committee shall function under the control of Chief Engineer (C-I&CC), Vidyuthi Bhavanam, Pattom.

1. Deputy Chief Engineer, Civil Circle, Kothamangalam (Chairman)
2. Smt. Salina P. (Emp. Code- 1058651), Assistant Executive Engineer, Boothathankettu SHEP. (Committee convener)
3. Sri. Anujith K. Babu (Emp. Code - 1108220), Assistant Engineer, Dam Safety Division, Idamalayar. (Master Coordinator)
4. Sri. Ananthakrishnan K.P. (Emp. Code - 1108214), Assistant Engineer, SPIN & Consultancy, Thiruvananthapuram.
5. Smt. Sheena L. (Emp. Code - 1049220), Sub Engineer, O/o the Chief Engineer (C-I&CC), Vidyuthi Bhavanam, Pattom.

Further to this it is necessary to serve a letter by the CMD, KSEBL to the Additional Chief Secretary (Finance), Government of Kerala, requesting permission for adopting E-M Book and E-Bill features of the PRICE 3.0 Software in KSEBL.

The matter was placed before Full Time Directors as per note read as 6<sup>th</sup> above.

Having considered the matter, the Full Time Directors resolved to accord sanction to appoint Sri. Anujith K. Babu (Emp. code.1108220) as Master Coordinator as point of contact with e-governance cell, PWD and National Informatics Centre, Kerala.

Further resolved to accord sanction to constitute an internal Technical committee as above.

Further resolved to accord sanction for taking up the matter with Government for adopting E-M Book and E-Bill features of the PRICE 3.0 Software in KSEBL.


