The Chief Engineer has informed that the excess kilometer (43.33%) was run during October 2023 in connection with the meeting of Chief Engineer (Generation) at Moolamattom, review meeting on Sabarimala Pilgrimage convened at Board level at Pathanamthitta Electrical Circle, for the to and fro transportation facility arranged to Sri. KK Rajan, Hydro Task Force member consultant, TNEB from Palakkad to Moozhiyar Generation Division Office in connection with inspection of vibration issues to unit No 4 at SGHEP (1192km) and for the service of the vehicle as ambulance, since the existing ambulance is aged more than 15 years.

Since these trips were essential and the same were performed for the bonafide purpose of KSEBL, the Chief Engineer (Generation) has requested ratification for the excess run performed in anticipation of the sanction from the Competent Authority.

Having considered the exigency of the matter, the Director (Gen-Elec, REES, S, S&W) hereby accords sanction for the excess 650 kilometre run for the month of October 2023 by the Department vehicle (TATA SUMO) KL-62B-5683 attached to the Generation Division, Moozhiyar and to ratify the excess run performed in anticipation of the sanction from the Competent Authority.
