<u>ORDER</u>

The Deputy Chief Engineer, Electrical Circle, Palakkad reported as per letter read as 1st above that, Sri.Murugan, S/o Karuppan, Kinarppalam under Electrical Section Velanthavalam is constructing a study room (part of the Padanamuri Project) for his son above which LT 3 phase line is passing through. An estimate amounting to ₹88,800/- is required to solve this issue. Considering the financial situation of the complainant and the safety issues in that area, the Deputy Chief Engineer, Palakkad suggested that necessary sanction may be accorded for executing this work. The Deputy Chief Engineer, Palakkad reported as per letter read as 2nd above that there are no other beneficiaries for the proposed line shifting and that the Vadakarappathy Panchayath has informed that no SC/ST fund is available for the proposed line shifting.

On detailed examination of the matter, the Deputy Chief Engineer Palakkad was directed to examine an alternate proposal requiring less expenditure, including line construction with ABC for establishing the safety clearance. The Deputy Chief Engineer, Electrical Circle Palakkad in the letter read as 3^{rd} above, put forth an alternate plan which involves insertion of 9m PSC Pole (2 nos) in the existing line. The estimate for this work amounts to ₹25004/-. It is reported that the statutory clearance can be maintained on the execution of this work. The Deputy Chief Engineer, Electrical Circle, Palakkad as per letter read as 4^{rth} above, reports that there are no other beneficiaries for this work. Additionally, the Secretary, Vadakarapathy Panchayath has informed that funds are not available for this work as well.

The matter was placed before the Full Time Directors as per note read as 6th above for a decision.

Having considered the matter in detail, the Full Time Directors resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Palakkad to carry out the work of "providing statutory clearance in the property of Sri.Murugan, S/o Karuppan, Kinarppalam under Electrical Section, Velanthavalam, Palakkad by inserting 2 No.s of 9m PSC Poles" at an estimated cost of ₹25004/-, using Board's fund, considering the poor financial condition of the beneficiary, as a special case.

Orders are issued accordingly.
