ORDER

The Managing Director, Horticornp as per letter read as 1st paper above requested to effect service connections to the bunks situated on the road sides, functioning as licensees of Horticornp, throughout the state without insisting for ownership documents, since for operating billing machine, refrigerator etc. electricity is essential.

As per rules in vogue, for effecting service connection to a premise, any document proving his ownership/possession of the building, or any other equivalent document from the revenue authorities is required as a proof of ownership or occupancy of the premises.

As per regulation 75 (5) (iv) of Kerala Electricity Supply Code, 2014, while submitting application form for new service connection for non-domestic kiosks, telecom tower and temporary structure no objection certificate for kiosk or temporary structure from the Municipal Corporation or Municipality or Grama Panchayat or land development authority or land owning agency shall also be submitted along with the application form.

Having examined the note read as 3rd paper above, the Full Time Directors in the meeting held on 02.04.2018 decided to

1. consider the request of the Managing Director, Horticornp to provide service connection to the bunks situated on the road sides, functioning as licensees of Horticornp, throughout the state without insisting for ownership documents, as a special case.
2. direct the Chief Engineers (Distribution) to effect service connection to such bunks, after executing an indemnity bond by the applicant that the service connection is liable to be disconnected, if the Secretary of the local body or any other statutory authority requests in writing to disconnect the service connection.

Orders are issued accordingly.
