The annual meeting of the Departmental Promotion Committee(Higher) for the ministerial wing was held on 29/12/2023 and the Select list was published as per Order read as (1) above wherein only one Assistant Accounts Officer who had satisfied the eligibility criteria was selected for considering for the post of Accounts Officer.

The Secretary (Administration) as per note read as (2) above has informed that Six Assistant Accounts Officers are remaining in the concerned gradation list and four of them have attained the required eligibility criteria to be considered for the post of Accounts Officer, as stipulated in Board Order read as (3). It was also informed that two Accounts Officers, Sri.Mathew C.T and Smt.Sivalatha M.G were served with reversion notice which has been stayed by the Hon'ble High Court of Kerala.

In accordance to the above the nominations of the remaining six Accounts Officers have been circulated among the members of the Departmental Promotion Committe (Higher) with remarks regarding the litigation in respect of the two Assistant Accounts Officers who has been served with reversion notice. All the members have approved the nominations of four Assistant Accounts Officers who have satisfied all the eligibility criteria.
