## NOTE TO ALL CONTROLLING OFFICERS

Sub: NOC for part-time B.Tech and Diploma courses – Request to follow the guidelines while forwarding applications – regarding.

Ref: 1. B.O. (FB) No.1667/2006 (Estt.IV/Part-time/NOC/05) dated 20.06.2006.

2. B.O. (FB) No. 1101/2007 (Estt.IV/7968/NOC/06) dated 09.05.2007.

3. B.O. (CM) No. 1831/2013 (EB7/NOC/Part Time Courses/2013) dated 26.08.2013.

KSEB Limited had prescribed certain guidelines for issuing No Objection Certificate to Board employees for part-time studies (B.Tech and Diploma), as per Board Orders referred above. But it is seen that many Controlling Officers are forwarding the applications of employees who apply for NOC for part-time studies without ensuring that the applicant is eligible to apply as per these guidelines. The guidelines for considering and forwarding the applications are as follows:

- 1. The applicant should have completed 1 year service after the date of declaration of probation in the entry cadre.
- 2. The applicant should have a minimum balance service of 10 years for retirement.
- 3. The application should be forwarded to this office along with the countersigned duly filled proforma for NOC for study purpose as per the B.O. referred 1<sup>st</sup> above (specimen enclosed).
- 4. The application for NOC and countersigned proforma should reach this office on or before 31<sup>st</sup> March every year.

All Controlling Officers are requested to adhere to these guidelines while forwarding the applications for NOC for part-time studies (B.Tech and Diploma) for the year 2024 and in future.
