5. The eligibility conditions for the post are as under:

- (i) **Maximum age limit** : 58 years as on the date of vacancy 01.03.2025.
- (ii) **Qualifications** : Officers of the Central Government, State Government or Union Territories or autonomous or statutory organization or Public Sector Undertaking or University or Recognized Research Institution:
 - (a) (i) holding analogous post on regular basis; or
 - (ii) holding post in Level-14 with five years of regular service in the grade; and
- (b) **Experience**: possessing three years' field experience in the relevant field as provided in sub section (5) of Section 70 of the Electricity Act, 2003.

6. The appointment shall be on deputation/short-term contract basis for a period of five years, subject to the condition that the services shall not be extended beyond the date of superannuation.
