## **ORDER**

A fatal accident occurred to a public named Sri.Babu on 28.06.2024 under Electrical Section, Marayimuttom. As per the report of accident submitted by the Sub Engineer i/c of the Electrical Section, Marayimuttom (2)nd read above, it is informed that the accident occurred from snapped conductor.

As per the Vydyuthi Suraksha Scheme of KSEBL (1) st read above, accident occurring from Snapped conductor (installation of KSEB Ltd) to public is included in category 'A' and are eligible for Rs.10,00,000/-(Rupes Ten Lakh Only) towards exgratia subject to the eligibility ascertained from a set of documents to be obtained from the field office and from the dependents of the deceased (9 No.s).

As the incident caused chaos and commotion among the public and the case drew widespread coverage in the media and also since the accident occurred from KSEB Ltd installation, the Chief Personnel Officer as per the note (3)rd read above recommended for sanctioning an immediate relief assistance amounting to Rs.5,00,000/-(Rupes Five Lakh Only) to the family of the victim considering the unfortunate mishap that leads to the loss of life.

Having considered the recommendation, sanction is hereby accorded for an immediate relief assistance amounting to Rs.5,00,000/- (five lakh only) immediately to the aggrieved family on humanitarian grounds .

The Executive Engineer, Electrical Division, Neyyattinkara shall arrange the payment of Rs.5,00,000/-(Rupees Five Lakhs only) and make necessary arrangements for the disbursement of the said amount to the mother of the victim after obtaining the receipt for the amount disbursed in the proforma enclosed. The receipt in original shall be forwarded to the office of the undersigned for records.

Orders are issued accordingly.
