## ORDER

A fatal accident is reported to have occurred to a public named Sri.Sudhan on 16.07.2024 under Electrical Section, Pulpally. As per the report mentioned in the news paper cutting, the accident occurred to the victim from the snapped conductor.

As per the Vydyuthi Suraksha Scheme of KSEB Limited read (1) above, accident occurring from snapped conductor (installation of KSEBL) to the public is included in category 'A' and is eligible for Rs.10,00,000/- (Rupees Ten Lakh Only) towards exgratia subject to the eligibility ascertained from a set of documents to be obtained from the field office and the dependent of the deceased (9No.s).

As the accident occurred raised chaos and commotion among the public and the case drew wide spread coverage in the media on account of its occurrence from KSEBL installations, demand has been raised by the dependents of the deceased and the representatives of the state for sanctioning an immediate relief assistance amounting to Rs.5,00,000/- (Rupees Five Lakh Only) to the family of the victim considering the unfortunate mishap that lead to the loss of a life of an young individual.

Having considered the above, sanction is hereby accorded for releasing an immediate relief assistance amounting to Rs.5,00,000/- (Rupees Five Lakh Only) immediately to the aggrieved family of the victim on humanitarian grounds and considering the unfortunate mishap that lead to the loss of a life.

The Executive Engineer, Electrical Division, Mananthavady shall arrange the payment Rs.5,00,000/- (Rupees Five Lakh Only) and make necessary arrangements for the disbursement of said amount to the family of the victim after obtaining the receipt for the amount disbursed in the proforma enclosed. The receipt in original shall be forwarded to the office of the Chief Personnel Officer for records.


