- ii)Commuted Value of Pension @ 40% of Service Pension Rs.42,22,707/-(Rupees Forty Two Lakhs Twenty Two Thousand Seven Hundred and Seven Only)

iii)Pension after Commutation Rs.47,555/-(Rupees Forty Seven Thousand Five Hundred and Fifty Five Only )+ Admissible DR

iv) Gratuity as per Payment of Gratuity Act 1972 is limited to Rs.20,00,000/-(Rupees Twenty Lakhs Only).

v)Family Pension at Higher rate Rs.79,257 /-(Rupees Seventy Nine Thousand Two Hundred and Fifty Seven Only)+ Admissible DR upto 29.03.2031. Thereafter at Normal rate Rs.49,920/-(Rupees Forty Nine Thousand Nine Hundred and Twenty Only)+Admissible DR to Smt.Deepa K R, wife of the pensioner subject to rules.

The retiring officer intended to draw pension and allied benefits from the Office of Executive Engineer, Electrical Division, Ernakulam.
