only) + admissible DR with effect from 01.06.2024 AN

2. Commuted value of Pension @ 40% of Service Pension Rs.44,32,896/- (Rupees Forty Four lakhs Thirty Two Thousand Eight hundred and Ninety Six only)

3. Pension after Commutation Rs.49,920/- (Rupees Forty Nine thousand Nine Hundred and Twenty only) + admissible DR

4. Gratuity as per Payment of Gratuity Act 1972 is limited to Rs.20,00,000/- (Rupees Twenty Lakh only)

5. Family Pension at Higher Rate of Rs.83,200/- (Rupees Eighty Three Thousand and Two Hundred Only) + admissible DR upto 19.05.2031 and thereafter at Normal Rate Rs 49,920/- (Rupees Forty Nine Thousand Nine Hundred and Twenty Only) + admissible DR to Smt Malathy Nair.S, wife of the pensioner as per rules.

The retiring officer intends to draw Pension and allied benefits from the Office of Chief Engineer(HRM)

The Accounts Officer, Pension Authorization shall authorize payment of pensionary benefits as specified above under intimation to this office.

Orders are issued accordingly.


