- 3.Pension after commutation is Rs.49,920/- (Rupees Forty nine thousand nine hundred and twenty only) + admissible DR.
- 4.Gratuity as per Payment of Gratuity Act 1972 and is limited to Rs.20,00,000/- (Rupees Twenty Lakh only)
- 5. Family Pension at higher rate Rs.83,200/- + (Rupees Eighty three thousand two hundred only) + admissible DR upto 30.05.2031 and thereafter at normal rate Rs.49,920/-(Rupees Forty nine thousand nine hundred and twenty only) + admissible DR to Sri K.M Abdul Salam , Husband of the pensioner subject to rules.
