ORDER

The Deputy Commandant, 27th Bn, Indo-Tibetan Border Police, Ministry of Home Affairs, GOI, Noornad vide letter read as 1st above, has forwarded a request to shift the RCC electric poles installed near the gate of the ITBP camp Nooranad, Alappuzha district using KSEBL's fund in public interest. It was stated that the electric poles are located near the turning point of the road and the entrance to the camp.

The gate is particularly sensitive as it is being used for the movement of heavy vehicles, buses, ambulances, etc during disaster response and other emergencies as well as in movements of troops, arms, and ammunition for various operational roles entrusted to the unit. Since the poles are situated outside the camp and are on a public road, the ITBP cannot bear the expenses as per their department rules.

The Deputy Chief Engineer, Electrical Circle, Harippad vide letter read as 3rd above, has reported that based on the field inspection the 11kV pole is currently installed near the gate of the ITBP camp which obstructs the movement of vehicles and that there is sufficient space to shift the pole to a convenient location, without interfering with existing structures. There are no technical issues in shifting the pole. An estimate amounting to Rs.77,574/- is required for shifting work. The work involves shifting of poles and insertion of one A pole to maintain statutory safety clearances.

Having considered the matter in detail, sanction is hereby accorded to the Deputy Chief Engineer, Electrical Circle, Harippad to execute the work of shifting of electric poles installed near the gate of ITBP camp Nooranad, Alappuzha district using KSEBL's fund, in public interest, as a special case, within an estimate amount of Rs.77,574/- as reported in the letter 3rd read above.

Orders are issued accordingly.
