Fatal accident occurred to Sri.Muhammed Rijas, a public under Electrical Section, Kovoov on 20.05.2024 – Immediate relief assistance – Sanctioned - Orders issued.

ORDER

A fatal accident occurred to Sri.Muhammed Rijas (18) on 20.05.2024 under Electrical Section, Kovoov. As per reference cited (2), the victim was electrocuted while accidentally coming into contact with the GI support of a shed in front of a shop room. It is reported that the earth leakage occurred from the WP service wire through GI sheet to the GI support.

As per the Vidyuthi Suraksha Scheme of KSEBL cited (3) above, accident occurring from snapped conductor wire and power leakage through earth wire, guy wire and stay wire etc (installation of KSEBL) are included in category 'A' and are eligible for exgratia amounting to Rs.10,00,000/- subject to eligibility. The documents required to ascertain the eligibility of accident for exgratia except first report of accident are not received.

The Form A report states that the accident occurred from Board installation and hence the above accident can be included under category 'A' of the Vidyuthi Suraksha Scheme. Accordingly, exgratia amount of Rs.10,00,000/- may be eligible subject to eligibility to be ascertained and confirmed based on necessary documents to be submitted.

As directed by the Hon'ble Minister for Power, the Private Secretary of Hon'ble Minister of Power has requested KSEBL to release an immediate relief assistance amounting to Rs.5,00,000/- (Five Lakh Only) to the family of the victim considering the unfortunate mishap leading to the loss of life of an 18 year old boy.

Note in this regard has been submitted to the Chairman and Managing Director vide reference cited (4) above. It has been ordered to take action as per the rules and is being done in the past.

Having considered the points as above in the Note 4th read above, sanction is hereby accorded for the immediate relief assistance amounting to Rs.5,00,000/- (Five Lakh Only) to the family of the victim on humanitarian grounds considering the unfortunate mishap leading to the loss of life of an 18 year old boy.

The Executive Engineer, Electrical Division, Feroke is authorized to arrange the immediate relief assistance amounting to Rs.5,00,000/- (Rupees Five Lakh only) immediately and make necessary arrangements for the distribution of the said amount to the family of the deceased. The receipt in original and the remaining documents necessary for ascertaining eligibility (8Nos.) for exgratia may be obtained and forwarded to the office of the undersigned at the earliest.

Orders are issued accordingly.
