**ORDER**

Sri Eby Kuriakose entered in KSEBoard's service on 03.10.1991 and retired

on superannuation on 28.02.2022 as Deputy Chief Engineer, Electrical Circle, Kottayam after rendering a Qualifying Service of 30 years.

The Chief Vigilance Officer (i/c) as per note read 4<sup>th</sup> above has informed that a CMP No.76/2020 was filed against Sri.Eby Kuriakose is pending disposal before the Hon'ble Principal Sessions Court Kottayam. Besides in connection with issuance of direct supply beyond the sanctioned period in respect of M/s Mangalam Publications(India) Pvt Ltd (HTB 28/22/2255) under Electrical Circle, Kottayam, Sri.Eby Kuriakose is included in the list of employees forwarded by the Chief Engineer (HRM) who are responsible for the financial loss occurred to KSEBL .

As per the Office Order read as 5<sup>th</sup> above, admissible Gratuity as per Payment of Gratuity Act, 1972 ,Rs.20,00,000/-(Rupees Twenty Lakhs only) sanctioned to Sri Eby Kuriakose , Deputy Chief Engineer(Rtd) based on the proposal of Chief Engineer(HRM) vide read 1<sup>st</sup> above.

As per office order read 7<sup>th</sup> above, Provisional Pension upto 75% of admitted value sanctioned to Sri Eby Kuriakose , Deputy Chief Engineer(Rtd) based on the proposal of Chief Engineer(HRM) vide Note read 6<sup>th</sup> above.

Later Sri Eby Kuriakose filed Writ Petition WP(C) No.4087 of 2023 before Hon'ble High Court of Kerala for granting full pension as well as commutation value of pension. The Hon'ble Court in it's judgement read as 9<sup>th</sup> above directed the Chief Engineer(HRM) to pass necessary orders for granting full pension as well as commutation value of pension to him within one month from the date of receipt of copy of judgement.

As per Office Order read as 10<sup>th</sup> above, Board has decided to comply with the Court direction as per the judgment dated 01/02/2024 read as 9<sup>th</sup> above.

Accordingly, as per office order read as 11<sup>th</sup> above pensionary claims in full was sanctioned to Sri Eby Kuriakose , Deputy Chief Engineer(Rtd) based on the proposal of Chief Engineer (HRM) vide Note read 8<sup>th</sup> above.

Based on the intimation as per letter read 12<sup>th</sup> above that , Smt Bindhu Eby, Wife of Sri Eby Kuriakose , had expired on 10.02.2022, Chief Engineer(HRM) vide note read 14<sup>th</sup> above requested to modify the Office Order dated 24.04.2024 excluding family pension(normal and higher rate) portion, for sanctioning pensionary claims in full to Sri Eby Kuriakose.

Having considered the request of Chief Engineer(HRM) , sanction is hereby accorded for revising the sanction order for settling the pensionary benefits in respect of Sri Eby Kuriakose, Deputy Chief Engineer, Electrical Circle, Kottayam retired on superannuation on 28.02.2022 vide PPO No.49033 by excluding sanctioning of family pension as detailed below.

(a) Superannuation pension @ Rs.83200/- (Rupees Eighty Three Thousand and Two Hundred Only ) plus admissible D.R w.e.f 01-03-2022 FN (.Pension already paid shall be adjusted in full and balance shall be disbursed)

(b) Commuted Value of Pension @ 40% of Service Pension Rs.44,32,896/-

(Rupees Forty Four Lakhs Thirty Two Thousand Eight Hundred and Ninety Six Only)

(c) Pension after commutation is Rs.49920/- (Rupees Forty Nine Thousand Nine Hundred and Twenty Only) plus admissible DR

Pensionary Benefits already paid may be adjusted in full and the balance amount is payable.

The retired Officer intends to draw Pension and allied benefits from Electrical Division, Pallom. The Accounts Officer, Pension Authorization shall authorize payment of pensionary benefits as specified above under intimation to this office.

Orders are issued accordingly.


