ORDER

As per KSERC (Renewable Energy and Net Metering Regulations), 2020, the distribution licensee shall at the end of the settlement period pay for the excess energy banked by the prosumers and captive consumers at the Average Pooled Power purchase Cost (APPC) of the licensee as approved by the Commission from time to time. As per the regulation, the "settlement period" means the period beginning from first day of October and ending with thirtieth day of September in the next Year for solar and for non-solar sources, the period from the first day of April in a year to the thirty first day of March in the next calendar year.

To enable the settlement of the energy banked by the grid connected solar generators in the state as on 30th September 2020, the APPC for the year 2020-21 as approved by the Hon'ble Commission is required.

Based on the power purchase cost approved by the Kerala State Electricity Regulatory Commission (KSERC) for the year 2019-20 vide order dated 8-7-2019 and the methodology fixed by the Central Electricity Regulatory Commission and adopted by KSERC for the calculation of Average Pooled Power Purchase Cost, Deputy Chief Engineer (Commercial & Planning) with full powers of Chief Engineer recommended to approve Rs.2.94/unit as the APPC for 2020-21 for payment to Renewable energy prosumers/Captive consumers at the end of settlement period.

The matter was placed before the meeting of Full Time Directors as per note read 2 above. Having considered the matter in detail, the Full Time Directors in its meeting held on 17-9-2020 resolved to approve Rs.2.94/unit as the APPC for 2020-21 for payment to Renewable Energy Prosumers/Captive consumers at the end of settlement period as per KSERC (Renewable Energy and Net Metering Regulations), 2020.

Orders are issued accordingly.
