ORDER

Purchase Orders read as 1st to 4th above were placed with M/s. Neccon Power & Infra Limited for the supply of various ACSR Conductors such as Wolf, Dog & Moose for the period from 2009 to 2011. The firm as per letter read as 5th to 8th above has requested to waive the penalty amount deducted towards belated supplies and to allow Price Variation. The firm had raised the same issues earlier, after completing the supply and reply to the firm was already given by the Chief Engineer (SCM) vide letters dated 18/08/2012 & 15/06/2012 that their request cannot be considered as per Purchase Order conditions.

In the case of Purchase Order read as 2nd above, the firm had supplied the material with in the delivery schedule. Hence Price Variation allowed as per updated basic price for the month of actual supply. An amount of Rs.61366/- was deducted by the consignee as penalty for the materials supplied after 15 days from the date of MDCC. The consignee, Executive Engineer, Transmission Stores Division, Angamally was intimated by the Chief Engineer (SCM) vide letter dated 15/10/2010 that the firm had completed the supply with in the delivery schedule and hence there is no need to impose penalty for the entire quantity. But the Executive Engineer, Transmission Stores Division, Angamally has informed vide letter dated 12/06/2023 that the amount is not seen refunded.

The matter is placed before the Chairman and Managing Director through the Director (Distribution, Safety, IT & SCM) explaining the issues raised by M/s. Neccon Power & Infra Limited for the supply of various ACSR Conductors such as Wolf, Dog & Moose for the period from 2009 to 2011. The Chairman and Managing Director directed to place the matter before the Board of Directors. Accordingly the matter was placed before the Board of Directors as per the note read as 11th above.

Having considered the matter in detail, the Board of Directors in the meeting held on 27/07/2023 resolved to authorize the Director (Distribution, Safety, IT & SCM) to decide the refund of the penalty amount of Rs.61366/-(Rupees Sixty One Thousand Three Hundred and Sixty Six Only) against the Purchase Order No.TCM.223/2010-2011/32 dated 06/04/2010 to M/s. Neccon Power & Infra Limited, if the claim of supplier is legally eligible.

Orders are issued accordingly.
