### ORDER

KSEBL preferred OS No. 627/2010 before the Hon'ble Principal Sub Judge, Thiruvananthapuram for realizing an amount of Rs.74,33,000/- (Rupees Seventy Four Lakh Thirty Three Thousand Only) along with interest from M/s Hindustan Construction Co. Ltd., in connection with a contract work awarded for the construction of concrete lined power tunnel of Lower Periyar Hydro Electric Project.

By the Judgment/Decree read as 1st above, the Hon'ble Principal Sub Judge, Thiruvananthapuram allowed the plaintiff Kerala State Electricity Board Limited to realize an amount of ₹74,33,000/- (Rupees Seventy Four Lakh Thirty Three Thousand Only) with interest @ 6% from the date of the suit till realization from the defendants and their assets, along with cost of the suit amounting to ₹3,46,671/- (Rupees Three Lakh Forty Six Thousand Six Hundred and Seventy One Only).

As per Office Order read as 2<sup>nd</sup>, it was decided to file Execution Petition before the Hon'ble Principal Sub Judge, Thiruvananthapuram for executing the decree/Judgment. As the assets of the defendant company are situated in Mumbai, Maharashtra, the Hon'ble Principal Sub Judge, Thiruvananthapuram as per Judgment dated 03.02.2022 in EP No.15/2022 in OS No.627/2010 read as 3<sup>rd</sup>, allowed the transfer of the decree to City Civil Court, Mumbai, Maharashtra and transferred the original Judgment/Decree as per Transfer Certificate read as 4<sup>th</sup> above.

Sri. John Thomas, Advocate vide the email read as 5th has requested the resolution authorizing the Chairman and Managing Director, KSEBL to represent Kerala State Electricity Board Limited in the proceedings of execution before the Hon'ble City Civil Court, Bombay. The matter was placed before the Full Time Directors as per note read as 6th above. Having considered the matter in detail the Full Time Directors in the meeting held on 28.03.2023 has resolved to authorize Dr. Rajan N Khobragade, Chairman and Managing Director, Kerala State Electricity Board Limited to represent Kerala State Electricity Board Limited in Execution Petition before the Hon'ble City Civil Court, Bombay, Maharashtra for execution of dated 21.12.2019 of the Hon'ble Principal Sub Judge, Decree Thiruvananthapuram in OS No. 627/2010 and to sign all papers, applications, plaints, petitions and documents, affidavits as may be required to be filed in the civil courts, criminal courts, High Courts, Supreme Court of India or before any other quasi-judicial authority, tribunals, arbitrators, government and/or local authorities in connection with any legal proceedings by or against the company or to represent the company in all other matters incidental thereto as may be considered necessary and expedient. Further resolved to place the matter before the Board of Directors for ratification.

Accordingly, the matter was placed before the Board of Directors for ratification as per the note read as 8<sup>th</sup>. Having considered the matter in detail, the Board of Directors in its adjourned 72<sup>nd</sup> meeting held on 27.07.2023 resolved to ratify the resolution of the Full Time Directors read as 7<sup>th</sup> empowering Dr. Rajan N Khobragade IAS, Chairman and Managing Director, Kerala State

Electricity Board Limited to represent KSEBL in all matters incidental to the filing of Execution Petition before the Hon'ble City Civil Court, Bombay for execution of the Decree read as 1st above.
