◆ RESOLVED TO allow the BG No.7005417BG0000018 dated 16-11-2017(Amended Guarantee No.0406320BG000003 dt.15-11-2021) worth Rs. 50,00,000/-, held presently in lieu of security deposit for 3 Purchase orders as the security deposit for the new P.O No.SCM i0/2023-24/931 dated 19-05-2023 also and as One Time Bank Guarantee in lieu of Security Deposits for future purchase orders that will be issued from the office of the Chief Engineer(SCM), with condition that M/s.United Electrical Industries should re-validate the BG up to the expiry of the guarantee period and 5% contract amount be retained as performance security till the satisfactory completion of the guarantee period of the items supplied.

◆ ALSO RESOLVED TO amend clause (3), 'Security Deposit' of the Purchase Order accordingly.
