## **ORDER**

Purchase Orders were placed with M/s. Vallikat Constructions as per P.O. read as I<sup>st</sup> above for the manufacture and supply of 56,500 Nos of 7m, 38,500 Nos of 8m and 9,000 Nos of 9m PSC poles to Electrical Circle, Thodupuzha and as per P.O. read as 2<sup>nd</sup> above for the supply of 12,500 Nos of 8m PSC poles to Electrical Circle, Ernakulam. M/s. Vallikat Constructions as per letter read as 3<sup>rd</sup> above have requested immediate order for a settlement of the contract without risk on either side and return of Bank Guarantees.

The matter was placed before the Full Time Directors in its meeting held on 05/06/2023, as per Note read as 4<sup>th</sup> above and it was resolved to accord sanction to the Director (D, IT & SCM) to issue notice to M/s. Vallikat Constructions to recover an amount of Rs.10,94,411/- towards the loss incurred by KSEBL by way of additional expenses for diversion of poles from other yards during the period of contract, as per the recommendation of Chief Engineer (SCM) as per Purchase Committee Note No. PSB.5/2004-05/Vallikat dated 27/02/2016 and subsequently based on the outcome of hearing.

Notice read as 5<sup>th</sup> above had been issued to M/s. Vallikkat Constructions to remit Rs.10,94,411/- towards the loss incurred by KSEBL by way of additional expenses for diversion of poles from other yards during the period of contract, within 7 days otherwise the amount would be realized by invoking the Bank Guarantees available with KSEBL.

In response to that, the Chief Manager of Canara Bank, Thodupuzha as per letter read as 6<sup>th</sup> above has informed that, Rs.10,94,411/- has been transferred to KSEBL's A/c as requested by M/s. Vallikkat Constructions, by breaking the FD kept as security for BG issued in favour of KSEB Ltd., for settlement of accounts of contract, and requested to release the Bank Guarantees amounting to Rs.28,34,075/-.

Since M/s. Vallikkat Constructions had remitted Rs.10,94,411/- towards the loss incurred by KSEBL by way of additional expenses for diversion of poles from other yards during the period of contract, as directed by KSEBL, the matter was informed to the Director (D, IT & SCM) as per Note read as 7<sup>th</sup> above with recommendation to finalise the contracts with M/s. Vallikkat Constructions for the supply of 7m, 8m and 9m PSC Poles to Electrical Circle, Thodupuzha as per Purchase Order read as I<sup>st</sup> above and the supply of 8m PSC Poles to Electrical Circle, Ernakulam as per Purchase Order read as 2<sup>nd</sup> above, and to release the Bank Guarantees amounting to Rs.28,34,075/- in favor of the supplier that expires on 31/07/2023. And the Director (D,IT & SCM) directed to place the matter before the Full Time Directors.

Accordingly the matter was placed before the Full Time Directors as per Note read as 8<sup>th</sup> above. Having considered the matter in detail, the Full Time Directors in its meeting held on 26/07/2023

**RESOLVED** to finalise the contracts with M/s. Vallikkat Constructions for the supply of 7m, 8m and 9m PSC Poles to Electrical Circle, Thodupuzha vide Purchase Order No. TCM.16/2005-06/352 dated 23.04.2005 and the supply of 8m PSC Poles to Electrical Circle, Ernakulam vide Purchase Order No. TCM.34/2005-06/893 dated 20.05.2005, and to release the Bank Guarantee amounting to Rs.28,34,075/- in favor of the supplier that expires on 31/07/2023, since M/s. Vallikkat Constructions had remitted Rs.10,94,411/- towards the loss incurred by KSEBL by way of additional expenses for diversion of poles from other yards during the period of contract, as directed by \* KSEBL.
