# ORDER

The delegation of powers of Ministerial Officers was revised as per Board Order read as 1<sup>st</sup> above. As per Clause 7.3.17 of this order, the Secretary (Administration) was empowered to hold an imprest of Rs. 1.5 lakh and to arrange recoupment as and when required.

However, as per note read as 2<sup>nd</sup> above, it was informed that the petty expenses met by the O/o the Directors, other offices under the ARU of Secretary (Administration), fuel expenses under Vehicle Monitoring Cell etc. are being paid from this imprest. Consequent on the hike of fuel charges and other expenses, the amount of Rs. 1.5 lakh is hardly sufficient for 10 to 15 days. This necessitates 2 to 3 recoupments of imprest every month. Therefore it was requested to enhance the limit of permanent imprest in respect of the Secretary (Administration) from Rs. 1.5 lakh to Rs. 2.5 lakh. As ordered by the Chairman & Managing Director, the matter was placed before the Full Time Directors as per note read as 3<sup>rd</sup> above.

Having examined the matter in detail, the Full Time Directors, in its meeting held on 07.07.2022 resolved to enhance the permanent imprest in respect of the Secretary (Administration) from Rs. 1.5 lakh to Rs. 2.5 lakh. Further resolved to place the matter before the Board of Directors for ratification.

Orders are issued accordingly.
