Review of electrical accidents occurred from February 2023 to June 2023 and safety activities and safety awareness programme conducted - constitution of committee to submit the report on human error in case of fatal accidents occurred from KSEBL's Installations - Orders issued.

ORDER

Sanction was accorded as per Board order read 1st above to conduct enquiry by Chief Vigilance Officer in all fatal electrical accident cases from Board Installations involving deliberate violation of “ Safety Procedures and Safety Policies” in KSEBL.

The details of electrical accidents that occurred from February 2023 to June 2023 and safety activities and safety awareness programme conducted were placed before the Board of Directors as per note read as 2nd above. The Board was informed that 32 Nos of fatal accidents had been occurred from February 2023 to June 2023, out of which one was KSEBL's staff. The Chairman explained that occurrence of fatal accidents to Board/Contract staff clearly point to the non adherence of SOP in this regard and cases occurring due to human error need to be investigated.

After discussion, the Board resolved to constitute a committee with the following members to submit the report on human error, if any, in case of fatal accidents occurred from Board Installations.

- i. Technical Officer (an officer not below the rank of Chief Engineer)
- ii. Experts from outside
- iii. Chief Vigilance Officer

It is further resolved to initiate disciplinary action imposing appropriate major penalty, if the human error of the officers /supervising officers is very clear in the report.

Also, resolved to modify the Board Order read as 1st above to the above extent.

Orders are issued accordingly.
