### ORDER

The Kerala Water Authority has requested sanction of KSEBL for some of their projects included in Jal Jeevan Mission. The matter was placed in the Full Time Directors meeting held on 26.04.2023 and it was decided to issue NOC for two drinking water projects of Kerala Water Authority. The Chief Engineer (Civil-Dam Safety & DRIP) as per the notes read as 1<sup>st</sup>, 3<sup>rd</sup> and 5<sup>th</sup> above & the Deputy Chief Engineer & PM, PES with full powers of Chief Engineer as per the note read as 4<sup>th</sup> above has recommended to issue permissive sanction for the following projects of KWA subject to certain conditions, considering the fact that the said projects are drinking water projects.

1. constructing intake well and pump house in Kulamavu lake (Vadakkapuzha) to construct 3 MLD water treatment plant in 40 cents of land in possession of KSEBL for providing drinking water to Arakkulam and Velliyamattom Panchayats.
2. Installing a floating raw water intake pump in Banasurasagar dam, Wyanadu.
3. Installing a floating raw water intake pump in Madupetty for generating 22 MLD water, for providing drinking water connections under JJM to Munnar - Pallivasal, Devikulam, Chinnakanal Panchayats.
4. Construction of Water Treatment Plant near Anchuruly.
5. Construction of a weir in Thonithadi

6. Construction of floating pump house in Madupetty dam
7. Construction of transformer control room near Madupetty dam
8. Construction of transformer control room and control panel near Ponmudi dam

The following conditions are to be stipulated while granting NOC/permissive sanction.

The implementation and operation of the said projects of Kerala Water Authority,

- i) Shall not adversely affect the day-to-day operation of the reservoir.
- ii) Shall not cause damages to the component structures of the project.
- iii) Shall not Impede access to the locations of the components.
- iv) shall not cause hindrance to the maintenance activities of the project required for ensuring the safety of dam and allied structures.
- v) Shall not cause hindrance for the smooth conduct of safety inspections & reservoir surveys.
- vi) Shall not obstruct the collection of important observations from various instruments installed for monitoring the health status of dam.
- vii) Shall be used only for the designated purpose.
- viii) Shall be responsible for obtaining necessary clearance/ NOC of the concerned departments such as Forest/Revenue.
- ix) Shall ensure that the implementation of the project of Kerala Water Authority shall be done in coordination with the field officials of KSEBL in charge of the project.

The matter was placed before the Full Time Directors as per the note read as 6<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 23.06.2023:

Resolved to grant NOC / Permissive sanction to the following Kerala Water Authority projects of Jal Jeevan Mission, proposed to be implemented in the land under the control of KSEBL, as per the Annexure 1 & 2 attached, subject to the conditions cited above.

#### **NOC**

1. Construction of WTP near Anchuruly
2. Construction of floating pump house in Madupetty dam
3. Construction of Weir in Thonithady
4. Construction of transformer control room near Madupetty dam
5. Construction of transformer control room and control panel near Ponmudi dam



**Permissive Sanction**

6. Construction of WTP near Mattupetty Dam - 100 cents
7. 2 cents of land under the ownership of KSEB needed for the construction of well cum pump house in kulamavu lake (Vadakkepuzha)
8. 40 cents of land needed under the ownership of KSEBL needed for the construction of WTP near Kulamavu lake (Vadakkepuzha)
9. Installing a floating raw water intake pump in Banasurasagar dam, Wyanad- 45 cents

Further resolved that while communicating to KWA, the decision taken in the meeting conducted by the Honourable Chief Minister regarding dues to KSEBL and Escrow account shall also be referred.
