Replacing the OH portion of Nallalam - Kuttikkattur 66kV single circuit line in the premises ULCyber Park with 110kV double circuit UG cable under deposit work in favour of M/s ULCCSS IT Infrastructure Pvt. Ltd - Revised Administrative Sanction accorded - Orders issued.

ORDER

The Administrative Sanction was accorded as per the B.O read as 1st above for the deposit work of "Converting and shifting the existing Nallalam - Kuttikkattur 66kV single circuit OH line inside the premises of ULCyber park with 110kV Double Circuit UG cable" in favour of M/s ULCCS IT Infrastructure Pvt. Ltd (ULCCS) at an estimated amount of Rs. 8,32,00,000/-.

As per the letter read as 2nd above the Chief Engineer (Transmission North) submitted a revised estimate amounting to Rs. 15,93,28,762/- (attached as annexure) for the deposit work due to revision of cost data and increase in the price of materials including 110kV UG cable. The estimate is prepared based on the DSR 2018, latest transmission cost data, labour data and the latest budgetary offer for cable works for materials and labour and deducting an amount of Rs. 6,47,161/- towards the cost of originally planned line upgradation and doubling of OH line under normal development work of KSEBL in the portion of Nallalam-Kuttikkattur.

The work includes

- Laying two circuits of 110kV 630mm2 UG cable (1300m) and 1330nm OFC from location 25 to 29 of the Nallalam-Kuttikkattoor line. One of the two circuits will be terminated at existing 66kV Cyber park Substation in a LILO arrangement.
- Dismantling 1040 m 66kV conductors including LILO portion, 1 no. D30 tower, 4 nos. D60 towers, 1 no. M30 tower, 2 nos. 66kV tapping towers and connected OH conductors (total 8 towers) and erection of new D6 towers at locations 25 & 29.
- The 110kV UG cable and OFC cable are to be laid by open trench and through HDD method.

The Chief Engineer also requested sanction to permit M/s ULCCS to execute the deposit work on their own, as requested by the beneficiary, after collecting the required supervision charges of Rs.1,21,78,398/- (including GST). The matter was placed before Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 15.06.2023 resolved to accord revised Administrative Sanction for the work of converting and shifting a portion of the existing Nallalm-Kuttikkattur 66 kV single circuit OH line inside the UL

Cyber park premises with 110 kV, 630 mm² double circuit UG cable on work deposit basis in favour of M/s ULCCS, Kozhikode at an estimate amounting to Rs. 15,93,28,762/- (including GST).

Further resolved to accord sanction to execute the work by the beneficiary themselves after remitting the required supervision charge of Rs. 1,21,78,398/- (including GST) to KSEBL and obtaining a well defined undertaking from M/s ULCCS incorporating the terms and conditions for executing the work, subject to condition that, if any amount in excess of already remitted supervision charges is incurred due to additions / modifications in the existing proposal, the same shall be borne by the beneficiary itself.

Orders are issued accordingly.
