## ORDER

The execution of E&M works of Peruvannamuzhy SHEP is fast progressing and scheduled to be completed in May 2023. For proper functioning of the power house, skilled staff is essential for operation and maintenance. The Deputy Chief Engineer (PED) with full powers of Chief Engineer as per the note read as 1<sup>st</sup> above has requested sanction for creating the following posts and to engage the operation and maintenance staff on contract basis by filling up posts of Sub Engineers with Diploma holders (Electrical) and Electricity worker with ITI (Electrical) qualification, till regular staff are posted.

It was also requested that the posting may be done sufficiently early so that adequate training and familiarisation regarding the plant operation and maintenance can be imparted prior to the handing over of power house to KSEBL by the contractor and also suggested that the station charge of

Chathankottunada SHEP which is the nearby power house may be given additional charge of the power house.

The matter was placed before the Full Time Directors as per the note read as 2<sup>nd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 06.03.2023 has resolved to approve the proposed staff pattern of Peruvannamuzhy SHEP (2x3MW) as proposed on contract basis.

Further resolved that the station engineer of Chathankottunada SHEP shall be given additional charge of Peruvannamuzhy SHEP also.
