Permission for Set Preparation for Film Shooting at Locations under KSEBL Possession - Additional Fee and Security Deposit for Days of Preliminary Activities such as Set Preparation - Sanctioned - Orders issued.

ORDER

KSEBL had revised as per the B.O. read as 1st above, the rates of fee for granting sanction for film shooting as ₹1,00,000/- plus applicable GST per day, under compliance of specific terms and conditions; and as per the letter read as 2nd above, the Executive Engineer, Office of the Chief Engineer (Civil-Dam Safety & DRIP) was entrusted as the Nodal Officer for Single Window Clearance for allotment of Dam sites and its premises for film shooting.

The Chief Engineer (Civil-Dam Safety & DRIP), as per note read as 3rd above reported that, Sri. Jamsheer Purakkattiri, Production Executive, "Theatre of Dreams" has requested permission for film shooting at Kizhakke Mattukkatta, Padukka, near reservoir area at Ayyapan Kovil, under Idukki Project, for a few days in March, with permission for additionally utilizing the site for preparing set for film shooting.

The Chief Engineer reported that the B.O. read above, stipulates only the terms and conditions on the film shooting and the fee applicable for the days of shooting, without any reference to the utilization of the locations for pre-shooting activities such as set preparation etc. It was also proposed that a fee @ ₹25000.00 (Rupees twenty five thousand only) plus applicable GST/day, may be collected from the film shooting agencies for the days in which preliminary activities such as set preparation for film shooting etc are made in the locations under the possession of KSEBL, adhering to the terms and conditions on remittance of fee as stipulated in the B.O. (FTD) No.2597/DGC/AEE-III/FS/2015 dated 06.09.2016 and that a Security Deposit of

₹1,00,000/- (Rupees One Lakh only) may also be collected from the applicants to safeguard the interest of KSEBL, which can be refunded after dismantling the set/temporary installations and clearing the site.

After examining the note read as 4th above, the Chairman & Managing Director accorded sanction for granting permission for preliminary activities such as Set Preparation etc on film fhooting at Locations under the possession of KSEBL, by collecting an additional fee @ ₹25000/- (Rupees Twenty Five Thousand only) plus applicable GST/Day. A Security Deposit of ₹1,00,000/- (Rupees One Lakh only) may also be collected from the applicants to safeguard the interest of KSEBL, which may be refunded after dismantling the set/temporary installations and clearing the site. This sanction shall also be subject to the condition that the set construction and its later removal must be done under the supervision of Dam Safety Engineer and that the site should be cleared in such a way that it was before the shooting. The rates of fee on shooting days and other terms and conditions shall remain as stipulated in the B.O. read as 1st above. It was also ordered to place the matter before the Full Time Directors later, for ratification. The Office Order read as 5th above was issued in this regard. Accordingly, the matter was placed before the Full Time Directors, KSEBL as per note read as 6th above for ratification.

Having considered the matter in detail, the Full Time Directors of KSEBL, in the meeting held on 06.03.2023, Resolved to ratify the following decisions:

1. Sanction accorded for collecting additional fee @ ₹25000/- (Rupees Twenty Five Thousand only) plus applicable GST/day, for the days of preliminary activities such as Set Preparation etc. on Film Shooting at locations under the possession of KSEBL. The rates of fee on shooting days and other terms and conditions shall remain as stipulated in the B.O. (FTD) No.2597 /DGC/AEE-III/FS/2015 dated 06.09.2016.

2. Sanction accorded for collecting the Security Deposit of ₹1,00,000/- (Rupees One Lakh only) from the applicants to safeguard the interest of KSEBL and may be refunded after dismantling the set/temporary installations and clearing the site.

Orders are issued accordingly.
