ORDER

The Chief Engineer (Generation) as per the letter read as 1st above has reported that the departmental vehicle bearing registration number KL-01-AS-9322, a 2008 model Ambassador car is being used by the Executive Engineer, Generation Division, Kozhikode. The vehicle is not in running condition due to various major defects that had developed.

It is reported that there are three subdivisions under Generation Division, Kozhikode i.e. Generation Subdivision, Kozhikode, KDPP Sub Division and Civil Maintenance Subdivision. There are eight SHEPs, KDPP and solar plant under this Division including Urumi 1 & 2 and Chembukadavu 1 & 2. Since the vehicle attached to Generation Division, Kozhikode is in garaged condition, it is very difficult to carry out the inspection of various SHEPs which is inevitable for the smooth functioning of the various stations. Quotations and tenders were invited in various occasions from Generation Circle, Kozhikode for hiring the vehicle but no valid bids received in the process. It was reported that contractors are hesitant to participate in tender as the normal trips are to SHEPs which are situated at hilly areas and are at far distances. Hence a vehicle is needed at Generation Division, Kozhikode at the earliest.

Considering the above, the Chief Engineer (Generation) has requested sanction to procure a new vehicle MAHINDRA BOLERO-B6, which is the best suited and economical vehicle for Generation Division, Kozhikode for an estimate amounting to Rs 13,00,000/- (Rupees Thirteen Lakh only) prepared based on the proforma invoice collected from M/s. ERAM motors Pvt. Ltd, Chungam, Feroke - the authorised dealer of Mahindra. Moreover sanction is also requested to survey report the existing 15 years old Ambassador car bearing registration number KL-01-AS-9322 at Generation Division, Kozhikode.

The matter was placed before the Full Time Directors as per the Note read as 2nd above for a decision.

The Full Time Directors in the meeting held on 17.02.2023 has resolved to accord sanction to procure a new vehicle MAHINDRA BOLERO - B6 for Generation Division, Kozhikode, for an estimate amounting to Rs 13,00,000/- (Rupees Thirteen Lakh only) from

Further resolved to condemn one or two vehicles which are the oldest and beyond repair.
