ORDER

The PRICE software was adopted in KSEBL for the estimation of civil works as per B.O. read as 1st above, in line with the direction from the Government of Kerala. Later, when KIIFB has made the estimate preparation in PRICE software mandatory for all the works funded by KIIFB with effect from 01.09.2020, as per the B.O. read as 2nd above KSEBL accorded sanction to incorporate the approved transmission data in PRICE software for preparation estimates for all works related to Transmission including TransGrid works. Subsequently, all the estimates of line construction works under TransGrid projects are being prepared in PRICE software.

The Chief Technical Examiner & Ex. Officio Secretary to Government as per letter read as 3rd above requested to submit the duly certified observed data/ market rates being used in KSEBL, reviewed by a Chief Engineer level committee, for consideration by the Inter Departmental Committee and incorporation in the PRICE software.

Accordingly, a Chief Engineer level committee was constituted as per Office Order read as 5th above comprising of Chief Engineer (Civil Investigation & Construction Central), Chief Engineer (Transmission South), Chief Engineer (Transmission North) and Chief Engineer (TransGrid) to verify and approve the transmission line and substation construction data prepared by the Committee of Experts (constituted as per Office Order read as 4th above) so that the validated final data can be submitted to the Government.

The Chief Engineer level Committee has finalized the transmission line construction/

maintenance and AIS substation construction/ maintenance data, and the same was placed before the Full Time Directors as per the note read as 6th above for approval.

Having considered the matter in detail, the Full Time Directors in the meeting held on 17.02.2023,

Resolved to approve the data pertaining to AIS substation construction/maintenance appended as Annexure 1A & 1B (424 Nos. of estimation data for works with 19 Nos. of observed material and labour component rates which is to be published as KSEBL market rate) and Transmission line construction/ maintenance appended as Annexure 2A & 2B (318 Nos. of estimation data for line works with 37 Nos. of observed material and labour component rates which is to be published as KSEBL market rate).

Further resolved to submit the data as above to the Government for consideration by the Inter Departmental Committee and incorporation in PRICE software.

Further resolved to authorize the Chief Engineer (TransGrid) to take necessary action in this regard.

Further resolved that Distribution wing shall submit the details for PRICE 3 software in a week.
