As per the PAP agreeement, KSEBL is entitled to utilise 12.3 TMC of water at Kerala Sholayar power house. For formulating a considered stand in the review of PAP agreement, the Chief Engineer (Civil - Dam Safety & DRIP) as per the note read as 2<sup>nd</sup> above has suggested to form an internal committee with Chief Engineer (Transmisson & System operations) and the Chief Engineer (Generation - Electrical) or their representatives.

The matter was placed before the Full Time Directors as per the note read as 3<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 25.01.2023:

Resolved to constitute an internal committee with Chief Engineer (Civil - Dam Safety & DRIP) as the Chairperson and Chief Engineer (Transmission & System Operations) and the Chief Engineer (Generation - Electrical) or their representatives as members to formulate a considered stand to be taken by KSEBL in the review process of the PAP (Parambikulam Aliyar Project) Agreement. Further resolved that the Committee shall present their recommendations before the Full Time Directors meeting and shall take respective position in the statutory Inter State Committees.
