ORDER

KSEBL as per the B.O read as 1st above had accorded sanction for the procurement of a Multi Activity Crane, ACE make (NXP 150) with man lift for the use at Idamalayar Power House, at an estimate amounting to Rs.44,30,000/- (Rupees Forty Four Lakh and Thirty Thousand only) by inviting open tender.

Now the Chief Engineer (Generation) as per the letter read as 2nd above, has reported that at the time of preparing the estimate for the above procurement, the ACE make (NXP 150 model) was not available in the GeM portal and presently, the above model is available in GeM portal and the Chief Engineer has requested sanction for the procurement through GeM portal, considering the price advantage of procurement through GeM portal.

The matter was placed before the Full Time Directors as per the note read as 3rd above.

Having considered the matter in detail, the Full Time Directors meeting held on 06.02.2023 resolved to accord sanction to carry out the procurement of a new Multi Activity Crane ordered as per B.O.(FTD) No.10/2023 (DGE/G3/Idamalayar Crane) dated 05.01.2023, at an estimate amounting to Rs.44,30,000/- (Rupees Forty Four Lakhs and Thrity Thousand only) including taxes, for the use at Idamalayar Power Station, through GeM portal.


