ORDER

Based on the sanction accorded as per B.O. read as 1st above to hire a diesel jeep or equivalent with driver for the official use of Assistant Executive Engineer (Civil), Quality Control Unit, Transgrid South, Kalamassery with monthly ceiling of 1500 km, the Deputy Chief Engineer (Transgrid South) had hired a vehicle for the period from 02.03.2022 to 01.03.2023.

Now the Chief Engineer (Transgrid) as per the letter read as 2nd above has reported that, the hired vehicle attached to Quality Control Unit, Transgrid South, Kalamassery usually exceeds the sanctioned monthly kilometer ceiling limit due to frequent trips made in connection with site inspection of the ongoing projects namely GIS project 2 (Construction of 400 kV GIS Substation, Kottayam), GIS project 4 (Construction of 220 kV GIS Substations, Ettumanoor & Vizhinjam), GIS project 5 (Construction of 220 kV GIS Substations, Kakkad & Pathanamthitta), AIS projects and many line works.

As per the guidelines of the funding agency KIIFB, the quality control wing must inspect the work sites at least once in a month and attend all major civil works. The quality control wing has also to accompany the KIIFB inspection officials during their site inspections.

The contract vehicle has already exceeded the monthly ceiling limit of 1500 km during 7 months out of the last 9 months, and that the present contract is expiring on 01.03.2023.

Hence, the Chief Engineer requested sanction for hiring a vehicle on contract basis for a further period of one year from 02.03.2023 with enhanced monthly kilometer ceiling limit of 2000 km for the use of Quality Control unit under TransGrid South, Kalamassery.

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 06.02.2023,

Resolved to accord sanction for hiring a vehicle on contract basis for a further period of one year from 02.03.2023 for the use of Quality Control unit under TransGrid South, Kalamassery with enhanced monthly kilometer ceiling limit of 2000 km.
