## ORDER

KSEBL has 9.0645 Ha of land at Kuzhinilam in Sy. No 13/3 of Mananthavady village in Waynad district which was acquired during the year 1980-83 for the implementation of Mananthavady Multi-Purpose Scheme and was under the custody of the Executive Engineer, Investigation Division, Kozhikode under the Chief Engineer (C-I&CC).

The Chief Engineer C-I&CC) as per the letter read as 1<sup>st</sup> above has reported that there is no field sub division in and around the said area and hence upkeep and maintenance of the property is very difficult. This land has been proposed for implementing 11MWp solar projects under PM KUSUM Scheme introduced by the Government of India as per B.O. read as 2<sup>nd</sup> above. The Chief Engineer requested sanction to hand over custody of the land to the Executive Engineer, Electrical Division, Mananthavady, in view of the proposal to set up the solar project.

The matter was placed before the Full Time Directors as per note read as 3<sup>rd</sup> above. Having considered the matter in detail, the Full Time Directors in the meeting held on 25.01.2023, Resolved to shift custodianship of 9.0645 Ha of land in Sy. No 13/3 of Mananthavady Village in Waynad district to the Executive Engineer, Electrical Division, Mananthavady to safe guard the interest of the utility in the long run.
