## <u>ORDER</u>

As per the Government of Kerala's EV policy, KSEBL is the State Nodal Agency (SNA) for Electric Vehicle charging infrastructure. In order to implement the government policy KSEBL, the SNA has decided to install EV charging stations and related works for private and public entities ranging from Government departments to private households on a work deposit basis. Wide publicity was made through Press Releases.

KSEBL, the owner of the largest network of charging infrastructure, has generated enormous expertise by setting up Electric Vehicle Charging Stations with different power ratings, makes and models. KSEBL's expertise in this field is expected to give the customers a chance to utilize the know-how of KSEBL at a nominal consultancy fee. Interested customers can choose any charger type and make an investment at their convenience. Further, the unified e-mobility software KEMapp of KSEBL will be available for EVCS operation & payment. The transformers, power extension works, and canopy cover as desired by the customer including a solar rooftop (optional) depending upon the feasibility will be planned and executed by KSEBL. All upstream and downstream electrification works and civil works in connection with this and quality assurance of the equipment will be undertaken by KSEBL.

KSEB Ltd envisages to empanel agencies for setting up EV charging Stations in customers' land in the State of Kerala through a transparent selection process. In these circumstances, as per note read as 2<sup>nd</sup> above, the Chief Engineer (REES) requested sanction for inviting Expression of Interest (EoI) for empanelling of agencies towards setting up of Electric Vehicle Charging Stations for private and public entities ranging from Government departments to private households in Kerala on a work deposit basis and to constitute a bid evaluation committee, since there is no precedence in KSEBL for processing/ evaluating such bids.

The matter was placed before the Full Time Directors as per note read as 2<sup>nd</sup> above. Having considered the matter in detail, the Full Time Directors, in its meeting held on 25.01.2023:

- 1. Resolved to accord sanction to float an Expression of Interest (EoI) for empanelling of agencies towards setting up of Electric Vehicle Charging Stations for private and public entities ranging from Government departments to private households in Kerala on a work deposit basis.
