**ORDER**

Two part tender was invited by the Chief Engineer (SCM) & CSC vide bid read as (2<sup>nd</sup>) above for the supply, installation and commissioning of Computer and its accessories(onsite warranty of five years) for a probable amount of contract of Rs.181568000/- based on BO read as (1<sup>st</sup>) above.

Five firms participated for the tender and the bids submitted by the bidders were evaluated to verify the conformity with KSEB Limited's technical requirement and commercial conditions. The remark of Financial Adviser was obtained and the bids were placed before the Pre-qualification Committee. The Pre-qualification Committee

held on 08.11.2022 discussed the matter in detail and decided to cancel the said tender, as no firms satisfied the financial criteria .It was decided to procure Computer and its accessories through CPRCS/Gem portal for the items available in the portal and other items through retendering with the approval from Board.

The Government as per GO read as (5<sup>th</sup>) above accorded sanction for implementing a centralized procurement Rate Contract System in Government for procurement of computers, printers, laptops etc. M/s. Keltron is entrusted as service provider for deriving rates of hardware items through e-tender. As per B.O read as (4<sup>th</sup>) all the purchases of the above materials in Government/Govt. owned entities must be procured through government site of [www.cprcs.kerala.gov.in](http://www.cprcs.kerala.gov.in).

Out of PCs, Dot Matrix Printers, network laser printers and UPS, only PCs and network laser printers are available in CPRCS portal. Hence it is proposed to procure 3628 Nos of PCs and 715 Nos of Network Laser Printers from CPRCS portal. Accordingly based on the two desktops models available in CPRCS portal matching with the technical specification of the requirement of KSEBL, and the network laser printers, amount was calculated and amounts to Rs.154378656/- and Rs.13118105/- respectively.

The matter was placed before the Full Time Director as per note read as (7<sup>th</sup>) above. Having considered the matter in detail, the Full Time Directors in its meeting held on 19/12/2022 resolved to procure the proposed hardware items through the Gem Portal.

Orders are issued accordingly.
