ORDER

The Chief Engineer (Civil - Construction) North reported as per the letter read as 1st above that an amount of Rs.2,37,94,050/- have been remitted by KSEBL during the year 2011 and 2013 towards the Award amount and establishment charges for the land acquisition of Vilangad Project as per the request of Special Tahasildar (LA General), Koyilandy and as per B.O s. read as 4 th and 5th above.

It was reported that an amount of Rs.1,00,000/- has also been remitted towards "Contingency Charges". However, after finalizing the land acquisition proceedings, the Tahasildar (LA General), Koyilandy as per the letter read as 2nd above forwarded a detailed expenditure statement and demanded a balance amount of Rs. 41,173/- towards establishment charges The details of amount remitted, actual expended and balance to be paid are tabulated below:

The matter was placed before the Full Time Directors as per the note read as 6th above

Having considered the matter in detail, the Full Time Directors of KSEBL in the meeting held on 28.12.2022, resolved to accord sanction to remit the balance amount of Rs.41,173/- (Rupees Forty One Thousand One Hundred and Seventy Three Only) to the Special Tahasildar, Land Acquisition General, Koyilandy towards establishment charges in connection with the land acquisition for Vilangad SHEP.
