ABSTRACT

Transferring 15.44 cents of land from the the compound of 110kV Substation, Koppam to Distribut on wing for the construction of Electrical Section Office, Koppam - Sanction accorded - Orders issued.

ORDER

Administrative sanction was accorded vide B.O. dated 30.09.2021 for the construction of a building for accommodating the Electrical Section office, Koppam under Electrical Circle Shornur. The Chief Engineer (Distribution North), as per letter read as 1st above, requested to transfer 17.64 cents of land in the compound of 110 kV Substation, Koppam to Distribution wing for constructing the Section office building.

The Chief Engineer (Transmission North) as per letter read as 2nd above, stated that after providing sufficient statutory clearances to the existing EHT line passing by the side of the proposed land and after considering the future developments of 110 kV Substation, 15.44 cents (25m x 25m) of land can be spared from 110 kV Substation, Koppam for the construction of the building, subject to the conditions that entry to the Section office building shall be provided from the tarred Substation - Karinganadukundu road and a compound wall of adequate height with anti-climbing arrangement shall be constructed immediately after the handing over the land.

The matter was placed before the Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 05.12.2022 resolved to accord sanction to transfer 15.44 cents (25m x 25m) of land from the compound of 110 kV Substation, Koppam to the Distribution wing for the construction of a building for accommodating Electrical Section office, Koppam subject to the condition that, entry

to the Section office shall be provided from the tarred Substation - Karinganadukundu road and a compound wall of adequate height with anti-climbing arrangement shall be constructed immediately after the handing over of the land.

Orders are issued accordingly.


