ORDER

The Chief Engineer (REES) as per note read as 8th above has reported that the Hon'ble KSERC as per order read as 5th above has ordered the following regarding the 'Request for selection of Wind Power Developers for setting up of 100MW Grid-Connected Wind Power Projects in Kerala under Tariff based competitive Bidding'.

Adopt L1 tariff of 3.96 per unit discovered in the tender for setting up of 100MW grid connected wind power projects in Kerala under competitive bidding route as detailed in the petition OP No. 48/2012. It was also ordered to reject request of M/s KSEBL to approve the offers of the bidders who offered power at tariff higher than the L1 tariff derived in the tender. Accordingly KSEBL decided to issue LoA to the L1 bidder M/s Aban Green Power Pvt. Ltd. alone.

Subsequently in the meeting held on 28.11.2022, M/s Inkel requested that in the light of the KSERC order, they may be given one more chance for L1 matching. The matter was placed before Full Time Directors as per note read as 9th above for a decision.

Having considered the matter in detail, the Full Time Directors in its meeting held on 05.12.2022 resolved to request the three L2 bidders viz. M/s Inkel Ltd., M/s Scoobee Day Garments (India) Ltd. and M/s Pioneer Wincon Energy Systems Pvt. Ltd. once again to match the L1 rate of Rs. 3.96 per kWh which is approved by the Hon'ble Commission

Orders are issued accordingly.
