ORDER

M/s. Garrison Engineers (NS), Military Engineer Services (MES), Kataribagh, Naval Base, Kochi has set up a 2 MW Ground Mounted Solar Power Plant at Naval Armament Depot (NAD), Aluva at Kadungalloor Village, Paravur Taluk, Ernakulam District in Captive Power Producer (CPP) mode with evacuation of power through KLED 1 & 2 feeder of 220 kV, Kalamassery Substation.

The Captive Consumer has requested KSEB Ltd for providing banking facility for the surplus solar energy injected from 2 MW Solar Power Plant after adjustment of their consumption of their consumer numbers listed in the scheduled drawee points. Also the Captive Consumer has executed a Connective Agreement read as 1st above with the Deputy Chief Engineer, Eletrical Circle, Perumbavoor and has executed long term open access agreement with the Chief Engineer (Transmission-South), Thiruvananthapuram as per LTOA agreement read as 10th above for connection of the 2 MW Ground Mounted Solar Power Plant at Naval Armament Depot (NAD), Aluva to use KSEB Ltd's Transmission or Distribution System to transmit electricity to and fro from the facility through the Intra State Transmission System.

The Captive Consumer has requested for availing banking facility for the 2 MW Solar Power Plant as per the provisions under Regulations 27 and 29 of the Kerala State Electricity Regulatory Commission (Renewable Energy and Net Metering) Regulations, 2020 as amended from time to time.

The Chief Engineer (Renewable Energy & Energy Savings) has requested sanction for execution of banking agreement with M/s. Garrison Engineers (NS), Military Engineering Services (MES), Kataribagh, Naval Base, Kochi for the 2 MW Solar Power Plant at NAD, Aluva,

The Chief Engineer (Renewable Energy & Energy Savings) has further submitted a draft banking agreement for the 2 MW Solar Power Plant at NAD, Aluva after incorporating the remarks of the Chief Engineer (Commercial & Tariff), Financial Advisor, Senior Law Officer and the Special Officer (Revenue). The draft banking agreement was acknoweldged by M/s. Garrison Engineers (NS), MES on 23.11.2022.

The salient features of the banking agreement are as follows:

- 1. The tenure of the agreement is deemed with effect from 29.11.2022 and valid for 25 years ie. up to 28.10.2047.
- Being a Long Term Open Access Consumer, rules and regulations applicable for Open Access Regulations followed by the KSEB Ltd will be followed by M/s. Garrison Engineers (NS), Milatiary Engineering Services (MES), Kataribagh, Naval Base, Kochi for execution of banking agreement for their 2 MW Solar Power Plant at NAD, Aluva.
- The settlement period to be decided as may be amended by the Hon'ble KSERC from time to time.
- 4. Solar energy generated from the grid integrated 2 MW Captive Solar Power plant shall be accounted to meet the RPO of the KSEB Ltd in view of the banking facility provided by KSEBL to the Captive Consumer. The Captive Consumer shall not have any rights whatsoever to accredit 2 MW Solar Power Plant under REC or to make use of the energy against its own Obligation, in case it is an obligated entity.
- 5. The settlement period to be decided as may be amended by the Hon'ble KSERC from time to time.
- 6. Solar energy generated from the grid integrated 2 MW Captive Solar Power plant shall be accounted to meet the RPO of the KSEB Ltd in view of the banking facility provided by KSEBL to the Captive Consumer. The Captive Consumer shall not have any rights whatsoever to accredit 2 MW Solar Power Plant under REC or to make use of the energy against its own Obligation, in case it is an obligated entity.
- The methodology for accounting, billing & settlement of banked energy would be as envisaged under clauses 27 and 29 of KSERC (Renewable Energy & Net metering) Regulation 2020 and its amendments and including the KSERC letter No. 2253/Con (T)/KSERC/2022 dated 26.09.2022 of the Secretary, Hon'ble KSERC.

The matter was placed before the Full Time Directors as per the note read as 12^{th} above. Having considered the matter in detail, the Full Time Directors in its meeting held on 05.12.0222,

Resolved to approve the draft banking agreement for providing banking facility towards the surplus solar energy injected from 2 MW Captive Solar Power Plant at

NAD, Aluva by M/s.Garrison Engineer (NS), Military Engineering Services (MES), Kataribagh, Naval Base, Kochi for execution of banking agreement after adjustment at specified drawal points located within the State, based on Regulations 27 & 29 of KSERC (Renewable Energy & Netmetering) Regulations, 2020 and its amendments and including KSERC order dated 26.09.2022 subject to the regulations in force.

Further resolved to authorize the Chief Engineer (REES) to execute banking agreement with M/s. Garrison Engineer (NS), Military Engineering Services (MES), Kataribagh, Naval Base, Kochi for 2 MW Captive Solar Power Plant at NAD. Aluva.

Orders are issued accordingly.
