## ORDER

KSEBL as per the B.O. read as 1<sup>st</sup> above has accorded sanction to hire or take on lease five numbers of apartments with a maximum monthly rent of Rs.25,000/- for the accommodation of Directors of KSEBL in Thiruvananthapuram. Subsequently, sanction has been accorded by KSEBL as per B.O. read as 2<sup>nd</sup> above to renew the rent agreement of the apartment No. 5(A) at Asset Lineage, Sasthamangalam, Thiruvananthapuram for a period of 11 months with effect from 12.01.2022 at monthly rent of Rs. 27,200/-.

The Chief Engineer (Civil-Construction) South as per the note read as 3<sup>rd</sup> above has reported that the period of rental agreement of the above mentioned hired apartment occupied by the Director (Transmission & System Operation) of KSEB Ltd. expires on 11.12.2022. The owner of the apartment informed his willingness to continue the rental agreement for another 11 months at the same rent and terms and conditions.

The Chief Engineer requested sanction for renewing the rental agreement of the hired apartment No. 5 (A), at Asset Lineage, Pipinmoodu Jn. Sasthamangalam, Thiruvananthapuram for a period of 11 months with effect from 12.12.2022 at the same monthly rent of Rs.27,200/- (Rs.24,200/- + maintenance charges of Rs.3.000/-) and at the same terms and conditions.

The matter was placed before the Full Time Directors as per the note read as 4<sup>th</sup>

Having considered the matter in detail, the Full Time Directors of KSEBL in the meeting held on 26.11.2022, resolved to accord sanction for renewing the rental agreement of the hired apartment No. 5(A) at Asset Lineage, Pipinmoodu Jn. Sasthamangalam, Thiruvananthapuram for a period of 11 months with effect from 12.12.2022 at a monthly rent of Rs.27,200/- (Rs.24,200/- + maintenance charges of Rs.3,000/-) with the same terms and conditions of the present agreement.
