ABSTRACT

ORDER

The Chief Engineer (Transmission North), as per letter read as 1 st above, reported that the Deputy Chief Engineer, Transmission Circle, Malappuram had invited competitive tenders for hiring a Tempo Traveler for the use of Line Maintenance Section, Malappuram for a period of ten months. The tender received was invalid and hence cancelled. In the re-tender invited on 10.08.2022, two tenders were received and the lowest rate of Rs.30/km is quoted by Sri.Abdul Saleem, Sabeena Manzil, Post office road, Areacode. After negotiation at various levels, he reduced his quoted rate to Rs.28.25/km.

The Chief Engineer reported that considering the present hike in fuel price, maintenance cost, tax, insurance, remuneration to driver etc. the quoted rate is reasonable and requested sanction to award the work to the lowest bidder at his regotiated quoted rate. The matter was placed before the Full Time Directors as per note read as 2nd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 14.11.2022, resolved to accord sanction for awarding the work of hiring a Tempo Traveler with driver for the use of Line Maintenance Section, Malappuram to the lowest bidder Sri.Abdul Saleem, Sabeena Manzil, Post office road, Areacode at his negotiated quoted rate of Rs.28.25/km, with a financial commitment of Rs.4,23,750/- for ten months for the sanctioned running distance of 1500km per month.

Orders are issued accordingly.
