ORDER

KSEBL had ordered as per B.O. read as 2nd above, to survey report all departmental cars / jeeps that are more than 20 years old, in line with the Government of India Used Vehicle Scrappage Policy. The Chief Engineer, Transmission South, as per letter read as 1st above reported that the department vehicles KCT 6337 attached to 220 kV Substation, Brahmapuram and KL07 5259 attached to 220 kV Substation Subdivision, Kalamassery under Transmission Circle, Kalamassery are included in List A of Annexure I to the said Board Order. Survey reporting process of the above vehicles had been initiated and steps were taken for hiring vehicles of 1500cc and above capacity for these field offices.The Chief Engineer, Transmission South has reported that even though tenders were invited twice for hiring vehicles for the use of above offices, nobody responded. It is also reported that it is very difficult to obtain a vehicle above 1500cc at the approved rate of KSEBL in Ernakulam.

220kV Substation, Brahmapuram, 220kV S/s, Ambalamugal, 110kV S/s, Kandanad and 66kV S/s, Puthencruz are under the control of Substation Subdivision, Brahmapuram. Kandanad and Puthencruz Substations are located about 25km and 15km respectively from the Subdivision head quarters and 220kV S/s, Ambalamugal is situated in a remote place where no conveyance facility is available. The Substation Subdivision, Kalamassery has control over 220kV S/s, Kalamassery and Power Transformer Repair Unit (PTRU) Kalamassery. Vehicle is highly essential for transporting materials / equipment for maintenance/ capital works and taking materials from Transmission Store, Angamaly. There is urgent requirement of vehicle for restoring power supply at any odd time and hence suitable vehicle with driver is indispensable in these offices.

The Chief Engineer has reported the following details of the existing vehicles.

In view of the above, the Chief Engineer requested sanction to reuse the vehicles KCT 6337 and KL07 5259 and to remit the insurance premium of these vehicles. The matter was placed before the Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 14.11.2022, resolved to accord sanction for using the vehicles, KCT 6337 attached to Substation Subdivision, Brahmapuram and KL07 5259 attached to Substation Subdivision, Kalamassery, which are included in the list of vehicles to be survey reported as per B.O. (FTD) No.93/2022/2021 (CE (REES) KSEB EVCS/2021-22) dated 02.02.2022, until suitable hired vehicles are obtained by tendering or new vehicles are allotted to these offices, whichever is earlier.

Orders are issued accordingly.
