Disposal of e-waste and hazardous waste available at various offices of KSEBL through the web portal of M/s.MSTC Limited – Sanctioned – Orders issued.

ORDER

The Conveners of Scrap Disposal Committee have been authorized as per Board Order read as 1st above to dispose off the e-waste and other hazardous waste generated in various offices of KSEBL by inviting limited quotations from the following three firms and to accept the highest offer;

- 1) M/s.Clean Kerala Company Limited
- 2) M/s.Al-Ameen Industries, Ernakulam
- 3) M/s.Venad Steel Corporation, Thiruvananthapuram.

It has been reported by the Conveners, Scrap Disposal Committees that the firms authorized to collect e-waste in KSEBL refuse to quote for items such as tube lights, CFL bulbs and incandescent bulbs and demanded to pay money to them for collecting these items.

The Chairman, Scrap Disposal Committee, Office of the Chief Engineer (Generation & PED) as per letter read as 3rd above had informed that there is a chance of obtaining high rate and better participation of bidders in the case of disposal of items such as transformer oil, lubricating oil by e-auction.

The matter was taken up with M/s.MSTC Limited and they had informed that the hazardous waste pertaining to KSEBL such as e-waste, transformer oil etc. can be sold/ disposed through their E-commerce portal in line with the existing e-auction procedure for the disposal of other scrap items of KSEBL as per the provisions of the Hazardous waste (Management, Handling and Trans-boundary Movement) Rules, 2011 and its amendments.

M/s.MSTC Limited has been appointed as per B.O read as 2nd above as a service provider for conducting e-auction on long term basis for approved items of scrap by paying them service charge of 2.5% plus GST (18%) on realized value of scrap. The pre-validated registered vendors of M/s.MSTC Limited participate in the auction and it is expected to be more effective increasing the competition and revenue realization.

The Chief Engineer (SCM & CSC) has suggested to dispose the e-waste and other hazardous waste generated in various offices of KSEBL through the web portal of M/s MSTC Ltd in a phased manner as per the prevailing terms and conditions of e-auction and recommended that the Conveners/Chairpersons of Scrap Disposal Committees at Regional level shall collect the circle wise details of scrap items available at various stores/offices and report the details in the e-auction format. The assessed value shall be Rs.10/Kg for e-waste and the minimum quantity of items to be reported for e-auction for a particular lot shall be 100 Kg. The assessed value of used transformer oil scrap is Rs.30/litre.

The matter was placed before the Full Time Directors as per note read as 5th above.

Having considered the matter in detail, the Full Time Directors meeting held on 26/10/2022 resolved to accord sanction for the disposal of hazardous waste items like e-waste, used transformer oil through the web portal of M/s.MSTC Limited as per the prevailing terms and conditions of e-auction.

Further resolved to authorize the Chief Engineer (SCM) for the disposal of waste materials in a phased manner with minimum lot wise quantity to be reported for e-auction as 100 Kg with assessed value of Rs.10/Kg for e-waste and Rs.30/litre for used transformer oil scrap.

Orders are issued accordingly.
