ABSTRACT

Appointment of Project Management Agency (PMA) for System Infrastructure works of KSEBL under RDSS scheme with price adjustment provision - Sanctioned - Orders issued.

ORDER

The Monitoring Committee for Revamped Distribution Sector Scheme (RDSS), Government of India, in the meeting held on 15.03.2022, approved the Action Plan and DPRs for Loss Reduction works and Smart metering submitted by KSEBL for a total amount of Rs.10,475.03 Crore, including the amount for Smart metering and Infrastructure - Loss Reduction Works, including the amount for Cochin Port Trust (now renamed as Cochin Port Authority).

The RDSS guidelines issued by MoP stipulate appointment of one or more Project Management Agency by each DISCOM for project formulation and project management, based on their requirement to cover different phases of the project. As per the terms and conditions of the sanction letter received from M/s.Power Finance Corporation Ltd (nodal agency) read as 1st above, KSEBL is to appoint Project Management Agency (ies) through tendering in line with the Standard Bidding Document (SBD) for PMA issued by Ministry of Power, Government of India for RDSS.

The scope of PMA includes preparation of tender documents, awarding, monitoring, quality assurance, material inspection, results evaluation or any other related work. As per the RDSS Guidelines and as per the sanction letter, Government Budgetary Support is restricted to 60 % of PMA charges @1.5% of the sanctioned Project cost for Distribution Infrastructure works and shall be sanctioned as a separate component of the scheme. The PMA charges, over and above the permitted amount shall be borne by the respective DISCOM/Government. The services of PMA shall be retained up to the physical completion of the project, without any financial implications beyond that already provided. Also, grant for PMA component shall be released on the basis of the sanctioned cost or award cost, whichever is lower.

KSEBL accorded sanction as per the B.O. read as 2nd above, to invite tenders for the appointment of Project Management Agency (PMA) for Distribution Infrastructure works under RDSS as per the Standard Bidding Document provided by MoP.

Accordingly, e-tenders were invited with

Probable Amount of Contract (PAC) - Rs.27 Crore,

Remuneration Structure - Remuneration with Price Adjustment Provision,

Type of tender - Single Stage Two envelope bidding process

Method of selection - Quality and Cost Based Selection (QCBS).

The PQ bid was opened on 01.06.2022. Two bidders, M/s. WAPCOS Ltd, Haryana & Joint Venture of M/s. Voyant Solutions Pvt Ltd, Haryana (Lead Partner/Authorised Representative of JV) & M/s. Feedback Infra Pvt. Ltd participated in the tender and submitted their technical and financial proposals. The evaluation committee constituted vide B.O. dated 02.06.2022 evaluated the received technical proposals and based on the evaluation, assigned the technical scores as follows.

M/s. WAPCOS Ltd, Haryana - 94 out of 100.

JV - M/s Voyant Solutions Pvt Ltd & M/s. Feedback Infra Pvt. Ltd - 94.88 out of 100.

The PQ committee constituted vide B.O. dated 14.07.2022 decided to prequalify both the bidders - M/s. WAPCOS Ltd and the JV - M/s Voyant Solutions Pvt Ltd & M/s Feedback Infra Pvt Ltd and approved the technical scores assigned by the Evaluation Committee. Subsequently, the financial bid was opened on 27.07.2022 and the abstract of the financial bid received is tabulated below.

As per the relevant clauses in the Instructions To Consultants (ITC) and bid data sheets, the price quoted shall be inclusive of all the applicable taxes and duties except GST which will be reimbursable by KSEBL against requisite documents as per actuals. Hence both the bidders had quoted the rate excluding GST. The evaluation committee evaluated the financial proposals received from the bidders and calculated the financial scores following the SBD clause.

After considering both technical and financial scores, the evaluation committee arrived at the final scores in QCBS method by adopting the weightage of 70 % for technical scores and 30% for financial scores as below.

1. JV - M/s Voyant Solutions Pvt Ltd and M/s. Feedback Infra Pvt. Ltd - 96.42 (Highest scorer) &

The successful bidder selected through the QCBS method, the JV - M/s Voyant Solutions Pvt Ltd and M/s. Feedback Infra Pvt. Ltd was asked to offer their rock bottom rate and M/s Voyant Solutions Pvt Ltd (Lead Partner) informed that they were adhering to the quoted price of Rs.11.43 Crore (Exclusive of GST) without change in their quoted amount.

The Chief Engineer (IT, CR& CAPS) as per the note read as 4th above recommended to award the contract for the consultancy service as Project Management Agency (PMA) for Distribution Infrastructure works of KSEBL & Cochin Port Authority (CoPA) under RDSS to the successful bidder selected through the QCBS method - JV - M/s Voyant Solutions Pvt Ltd & M/s Feedback Infra Pvt Ltd at their quoted rock bottom price of Rs.11.43 Crore (inclusive of all applicable taxes and duties except GST) with yearly price adjustment provision.

Having considered the matter in detail, the Full Time Directors in the meeting held on 31.08.2022, resolved to accord sanction to issue LoA, for the Appointment of Project Management Agency for System Infrastructure works of KSEBL & Cochin Port Authority under RDSS scheme in favour of JV - M/s Voyant Solutions Pvt Ltd and M/s Feedback Infra Pvt. Ltd, at their quoted rock bottom price of Rs.11.43 Crore (inclusive of all applicable taxes and duties, except GST) with yearly price adjustment provision.

Orders are issued accordingly.
