The suit was originally filed as OS No. 81/2014 and filed before the Hon'ble Sub Court, Thiruvananthapuram by M/s York Construction Engineers and Contractors against KSEBL for releasing payment in connection with the contract work of construction of 'E' type flats at 66 KV Sub Station, Mankavu, Kozhikode. The suit was later transferred to the Commercial Court and renumbered as Com. Suit No. 176/2021. The Chairman and Managing Director, KSEBL had accorded sanction to authorize Sri. Chandra Babu P and Sri. Anil Kumar M to adduce evidence in Com. Suit No. 176/2021 as per Office Order read as 2<sup>nd</sup> above and ratified by the Full Time Directors as per B.O read as 3<sup>rd</sup> above.

The Chief Engineer, Transmission (North), Kozhikode as per letter read as 4<sup>th</sup> above has requested to exempt Sri. Chandra Babu P, Deputy Chief Engineer (Retired) from adducing evidence in the subject case and nominated Sri.
