KSEBL as per BO read as 1st above had accorded sanction for taking membership in M/s HPX. As per M/s HPX's membership proposal, a member settlement bank account has to be opened in ICICI Bank.

The Chief Engineer (Transmission & System Operations) was authorized as per BO read as 2nd above to open and operate an account in ICICI bank at Ernakulum for transactions with M/s HPX.
