ORDER

M/s Uduppi Kasargod Transmission Company limited (UKTL) is a SPV under Sterlite Power Grid Ventures Ltd (SPGVL) executing the transmission project awarded by Government of India Under Tariff Based Competitive Bidding (TBCB). The scheduled commercial operation date of the project is 11.11.2022.

As requested by UKTL, KSEBL as per the B.O read as 1st above, had nominated Sri. Pradeep Kumar K, Assistant Executive Engineer, Line maintenance Sub Division, Mylaty as the Nodal officer of KSEBL for supporting UKTL in the settling of RoW compensation, crops damage compensation etc in connector with the execution of the project.

Since Sri. Pradeep Kumar retired from KSEBL on superannuation on 31.05.2022, UKTL requested to appoint a new nodal officer. The Chief Engineer (Trans. North) as per letter read as 3rd above recommended the request from M/s UKTL to nominate Sri. Pradeep Kumar, AEE (Ptd), LMSD, Mylaty as the nodal officer considering his experience in line construction and his satisfactory service as the nodal officer until retirement, subject to the condition that the expenses in this regard are met by the firm. UKTL agreed to the appointment of Sri. Pradeep Kumar as Nodal officer and also agreed to bear the expenses. The matter was placed before the Full Time Directors as per note read as 4th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 1.08.2022, resolved to nominate Sri. Pradeep Kumar K, Assistant Executive Engineer (Retired), who had been working as the nodal officer from KSEBL side to support M/s UKTL in settling the RoW compensation issues, crops damage compensation etc. in connection

with the implementation of Uduppi-Kasargode 400 kV transmission project till his retirement on 31.05.2022, as the Nodal Officer for a further period of six months with prospective effect, subject to the condition that the expenses towards the remuneration shall be directly paid to him by M/s UKTL.
