ABSTRACT

TransGrid 2.0 - Implementation of Ramakkalmedu Green Corridor project - Setting up of field offices - Sanction accorded - Orders issued.

ORDER

The Ramakkalmedu Green Corridor (RGC) project was approved under the GEC II scheme of MNRE as per letter read as 2nd above. The project comprises construction of 33/110 kV substation at Anakkaramedu, construction of 220 kV substation at Nirmala City, construction of 9 km, 110 kV DC line from Anakkaramedu to Nedumkandom, construction of 20 km, 220/110 kV MCMV line from Nirmala City to Kuyilimala LILO point and 5 km 110 kV DC line from Nirmala City to Kattappana and construction of 2 Nos of 110 kV bays each at Nedumkandom and Vazhathope substations. As per the guidelines of GEC II scheme, the works should be tendered and awarded to the contractors within a period of 2 years, i.e. by 31.12.2023.

As per B.O. read as 1st above, KSEBL had approved the organization structure for TransGrid project by redeployment from other offices. As per the B.O. on completion of each work, the places can be shifted to the next site or can be deployed elsewhere on completion of the entire project. Hence, the Chief Engineer, TransGrid, as per note read as 3rd above, requested sanction for shifting and renaming of the offices whose entrusted works are in finishing stage.

The Chief Engineer reported that the location of the proposed 220 kV substation at Nirmala City is identified and the land acquisition process needs to be expedited. Further, ANERT has consented to transfer land for constructing the 33/110 kV pooling station at Pushpakandam near Anakkaramedu and its location is also finalized. The profile survey of the 110 kV line from Pushpakandam to Nedumkandom is to be carried out urgently before proceeding with tender formalities. Hence, field offices with sufficient competent staff are to be set up at project locations for conducting preliminary works.

The TransGrid TC Sub Division, Pallivasal (Kothamangalam) initially formed as part of TransGrid execution special team, was entrusted with the construction of 220 kV substations Kothamangalam & Chithirapuram and construction of 90 km 220/110 kV Aluva-Pallivasal MCMV line. The ongoing works under this Sub Division and TransGrid Civil Sub Division, Kothamangalam under the jurisdiction of Deputy Chief Engineer, TransGrid South are at finishing stage and hence it is suggested to shift these two Sub Divisions to Idukki with headquarters at Kattappana for the execution of Ramakkalmedu Green Corridor project.

The Head Quarters of the two Sub Divisions are proposed at Kattappana considering the ease of access to work locations. Since KSEBL does not possess any office building at Kattappana, the proposed offices has to be accommodated in rented buildings as per the prevailing norms. The staff and vehicles now attached to these two Sub Divisions can be utilized for the proposed offices. The vacant places of the officers/ staff are required to be filled up for timely execution of the projects.

The matter was placed before the Full Time Directors as per the note read as 4th above.
