#### ORDER

As per the provisions of Sec. 204 of the Companies Act 2013 and Rule 9 of the (Appointment and Remuneration of Managerial Personnel) Rules 2014, secretarial audit is required to be conducted by an independent practicing Company Secretary, if the company, is a listed Company or is a public company having paid up share capital of ₹50 Crore or more or is a public company having a turnover of ₹250 Crore or more during the financial year. As KSEBL satisfies the above two conditions, Secretarial Audit has to be conducted by a Practicing Company Secretary or by a firm of Practicing Company Secretaries.

M/s PI & Associates, D-38, South Extension Part-1, New Delhi-110049 represented by Dr. Baiju Ramachandran FCS, A-80, Deepam, Deshabhimani Road, Thampanoor, Thiruvananthapuram- 695 001, a firm of Practicing Company Secretaries was appointed as the Secretarial Auditors for 2019-20 at their quoted fee of ₹49560/-(Rupees Forty Nine Thousand Five Hundred and Sixty only) inclusive of all taxes, charges and all out of pocket expenses. The same firm was appointed for the year 2020-21 at the same terms and conditions for 2019-20.

M/s PI & Associates, as per letter read as 4<sup>th</sup> above has intimated their willingness to carry out the Secretarial Audit for the year 2021-22 with the same terms and conditions as that of Financial Year 2019-20 and 2020-21.

As per Rule 8 of the Companies (Meeting of the Board and Its Powers) Rules, 2014, the power to appoint Secretarial Auditor has to be exercised by the Board of Directors by means of a resolution passed at a meeting of the Board. Hence the matter was placed before the 66<sup>th</sup> meeting of the Board of Directors held on 27.07.2022 as per note read 5<sup>th</sup> above.
