## **ABSTRACT**

## ORDER

The Deputy Chief Engineer with Full Powers of Chief Engineer (PED) reported that the machine in Poringalkuthu SHEP is in service after 04.06.2022. A few supplies like spares, tools and plant and transformer oil tank etc. are pending. Out of this, supply of excitation spares (foreign supply) is very critical since failure of any parts in excitation panel may cause loss of generation. Some of the items which are found not working properly during commissioning tests like vibration monitor display units, shaft current CT, HMI of Excitation panel etc. are to be replaced by the contractor. The taking over of the project is yet to be done. Now the E&M contractor requested to release a part payment of Rs.1,00,00,000 for making 100% advance payment to M/s. Hunan-Allonward for the supply of Excitation spares.

As per clause 1(b) of the Supply order read as 2<sup>nd</sup> above 15% of the FOR value of materials shall be paid after taking over of unit. As per clause I (ii) of the work order read as 3<sup>rd</sup> above, 20% of the erection charges shall be paid after taking over of the unit. 15% value of the materials already supplied till date and which are working satisfactorily (Not faulty) comes to Rs.4,80,29,842/- and 20% of the erection bills passed till date comes to Rs.30,59,520/-. Total of the above two comes to Rs.5,10,89,362/-. Out of the above, an amount of Rs. 1,50,00,000/- is already released as per the B.O. read as 4<sup>th</sup> above. The balance amount that can be released comes to Rs.3,60,89,362/-. This amount will become due only on taking over of the unit.

The partial discharge analyzer already supplied is found not working during commissioning and the same is taken back by the contractor for replacement or repair. The value of amount paid towards 80% of FOR Value of partial discharge analyzer to the contractor comes to Rs.44 Lakhs. After deducting this amount, the balance amount comes to Rs.3,16,89,362/-. The Deputy Chief Engineer (PED) with Full Powers of Chief Engineer has reccomended that as this amount can be claimed by the contractor after

taking over of the unit and since spares for excitation system are needed urgently at site, the request from M/S. SSIPL, the E&M contractor,to release a part payment of Rs. 1,00,00,000/- can be considered.

The commissioning of the project was delayed not due to the fault of the E&M contractor. The E&M contractor has commissioned the unit in a short period of time after water was made available in the water conducting system and the machines are in service now. The project completion period was extended for a long period and commissioning of the project was delayed due to no fault of the E&M contractor. Considering the report from the Deputy Chief Engineer (PED) with Full Powers of Chief Engineer, it was recommended to release Rs.1,00,00,000/- (Rupees one Crore only) which is 31.55 % of Rs.3,16,89,362/-.

The matter was placed before Full Time Directors as per the note read as 5<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 22.07.2022 has resolved to accord sanction for releasing Rs.1,00,00,000/- (Rupees One Crore only) to the E&M contractor of Poringalkuthu SHEP (1X24 MW) from the amount, which will become due to the contractor on taking over of the plant so that the procurement of mandatory spares of excitation system can be arranged, considering that the project commissioning was delayed not due to the fault of the E&M contractor.

Orders are issued accordingly.
