ORDER

The Chief Engineer (Civil-Dam Safety & DRIP) as per the Note read as 1st above has reported that Dr. Anvar Ali PH, Assistant Professor, KUFOS (Kerala University of Fisheries and Ocean Studies) & Principal Investigator (KUFOS Project), Pancode P.O, Kochi has requested to provide the service of the boat owned by KSEBL at Idamalayar for undertaking sampling study on fishes in the Idamalayar Reservoir for a period of 3 consecutive days as part of his project.

The KUFOS Project is funded by the United Nation Development Program (UNDP). Government of Kerala have permitted fish farming in the Reservoirs of Kerala and seeds in large number have been placed in the Idamalayar Reservoir area.

The Chief Engineer (Civil - Dam Safety & DRIP) has suggested to consider the request of Dr. Anvar Ali PH, Assistant Professor, KUFOS & Principal Investigator (KUFOS UNDP Project), Pancode P.O, Kochi to provide the service of the boat owned by the KSEBL for three consecutive days subject to the compliance of specific conditions by the Principal Investigator / Survey Team.

The matter was placed before the Full Time Directors as per Note read as 2nd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 15.07.2022, resolved to accord sanction to the Chief Engineer (Civil-Dam Safety & DRIP) to permit Dr. Anvar Ali PH, Assistant Professor, KUFOS & Principal Investigator (KUFOS Project), Pancode P.O Kochi for providing the service of the boat owned by KSEBL for three consecutive days for conducting field survey and sampling in the Idamalayar Reservoir subject to the following conditions:

1. Labour Charge for the Syrang for 3 days @ ₹730/day, Daily Rent for the boat @ ₹1000 and Fuel Charge @ ₹9 litre / hr shall be remitted by the applicant.
2. KSEBL shall not be responsible for any activity violating the regulations of Forest Conservation or any other similar act that may occur during the sample survey.

3. Sampling shall be permitted between 6.00 am to 6.00 pm only.
4. Daily activity/status report shall be provided to the KSEBL.
5. Personnel security in all aspects should be ensured.

The Chief Engineer (Civil-Dam Safety & DRIP) shall take further necessary action in this regard.
